Spouse Funeral Benefit Terms & Conditions

‘Spouse’ means a married or de-facto partner of a current QRI Lifestyle member. Spouse funeral benefit is only available if the primary member is a current member of QRI Lifestyle. Spouse membership will cease if the primary membership is lapsed, cancelled or suspended for any reason. Membership period is from the date you join until June 30 each year and all entitlements to membership benefits will cease if membership fees payable are not paid up to date and/or by the due date. Important Notice for \$40 Spouse Funeral Benefit:

Your QRI Lifestyle spouse funeral benefit may provide funeral benefit payable upon death. It is a condition of membership that you comply with the Duty of Disclosure (explained below) and complete the following questions:

Have you been declined life insurance cover before? Yes/No

Have you been told by a medical professional that you have a life threatening health condition? Yes/No

If you answered yes to either of these questions, contact QRI Lifestyle to arrange a full application form.

Duty of Disclosure - On joining QRI Lifestyle with Funeral benefit included, you have a legal duty (under the Insurance Contracts Act 1984) to disclose any matter that you know (or could reasonably be expected to know) is relevant to the insurer’s decision to issue the insurance cover. Your duty does not require disclosure of a matter that diminishes the risk to the insurer, is of common knowledge, is already known (or ought to be known) by the insurer, or is a matter to which compliance with your duty has been waived by the insurer. If you fail to comply with the duty of disclosure and the insurer would not have offered cover on any terms if the failure had not occurred, the insurer may, within 3 years, cancel the cover or reduce the sum insured. If your failure is fraudulent the insurer may cancel cover at any time.
