QRI Lifestyle was founded in 1894 as a social club for QR employees. Today, QRI Lifestyle is a self funded business entity. The organisation is a not for profit and is incorporated under the Queensland Associations Incorporation Act, 1891.

To this end, our administration and affairs are overseen by a State Management Committee, which is comprised of members elected by other members every two years. A General Manager heads up the organisation's dedicated staff including customer service, administration, marketing, business development, finance, insurance, and regional halls. The General Manager reports to the State Management Committee.

The organisation administers and delivers a vast range of leisure and lifestyle products and services from the State Office situated in Brisbane, as well as operating Licensed clubs in Gladstone, Toowoomba, Bowen and Coppabella. We also have a network of branches, social and sporting clubs throughout Queensland which are run by volunteers and local committees and report to the State Management Committee through the QRI Lifestyle State Office.

Through effective management and decision making which reflects our values, QRI Lifestyle's vision is to be the preferred choice for leisure and lifestyle benefits.

Role of the State Management Committee

The State Management Committee Members of Queensland Railways Institute Inc. (QRI) have a defined set of corporate governance obligations and responsibilities arising from applicable legislation, the QRI Constitution and accepted codes, policies and guidelines and accepted community standards. They must work amicably with the stakeholders including all QRI Members, the General Manager of QRI who is their chosen professional to provide advice on the operations of QRI to them for consideration through the Management Committee.

The major corporate governance obligations and responsibilities of the State Management Committee Members include:

- providing strategic leadership and direction to the QRI;
- monitoring the financial performance of QRI;
- eliminating where possible or else minimising risks;
- providing assistance to the General Manager;

The Committee is comprised of between eight to ten members who are elected every two years at the Annual General Meeting of the Association.

Executive: consists of a President, Vice-President, Secretary, Treasurer

General Committee: consists of minimum of 4 and maximum of 6 members

The State Management Committee serves a term of two years, until the next election when members can re-stand for election. The upcoming term is from October 2026 until the Annual General Meeting and Election in 2028.

Meetings of the State Management Committee are held bi-monthly. Most meetings will be held at the QRI Lifestyle State Office in Brisbane, while one or two meetings each year will be held regionally.

Members of the State Management Committee are required to attend various corporate and social events, regional branch tours, and other meetings of the association in an official capacity. Normally only the executive members are required to deliver speeches, presentations and reports at such events, however from time to time the general committee members may also be required to perform such duties.

State Management Committee members are required to be positive advocates of the organisation at all times and must act responsibly, diligently and with integrity.

Travel and accommodation expenses where required are paid for by the organisation and any legitimate and approved out of pocket expenses incurred in the course of QRI Lifestyle engagement, will be reimbursed.

Being part of the QRI Lifestyle State Management Committee is a very rewarding and fulfilling experience and the organisation encourages any member with relevant skills and experience to nominate for the 2026-2028 term.

Election Process

Election of all QRI Lifestyle State Management Committee positions for November 2026 – October 2028 will be **held on Thursday 29th of October, 2026** at the Annual General Meeting (AGM) of the Association.

If the total number of applications received for each of the positions exceeds the maximum number required then voting by financial members of QRI Lifestyle will be required. If voting is required then there will be a ballot available for members to vote. Members may vote either by postal vote up to 72 hours prior to the AGM or in person at the AGM. Members can vote only once.

Members can be nominated for one or more positions, but can only be elected to one position.

Voting is treated in confidence and only the Returning Officer (as appointed by the State Management Committee prior to calling for nominations), views and tallies the votes. The Organisation's Auditors will verify the results.
